To be eligible, the following criteria must be met:

- Proof of residency in Warren Township and child's birth certificate
- Age 3 by October 1, 2019 for the three year old children
- Age 4 by October 1, 2019 for the four year old children
- Students eligible for entrance into kindergarten in September 2019 will not be considered for enrollment in the four year old preschool program.
